AKTA CUKAI AKTIVITI PERNIAGAAN LABUAN 1990

PERATURAN-PERATURAN CUKAI AKTIVITI PERNIAGAAN LABUAN (BORANG) 2013

PADA menjalankan kuasa yang diberikan oleh seksyen 21 Akta Cukai Aktiviti Perniagaan Labuan 1990 [*Akta 445*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Cukai Aktiviti Perniagaan Labuan (Borang) 2013**.

LABUAN BUSINESS ACTIVITY TAX ACT 1990

LABUAN BUSINESS ACTIVITY TAX (FORMS) REGULATIONS 2013

IN exercise of the powers conferred by section 21 of the Labuan Business Activity Tax Act 1990 [*Act 445*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Labuan Business Activity Tax (Forms) Regulations 2013**.

(2) These Regulations are deemed to have come into operation on 11 February 2010.

Forms

2. The Forms to be used for the purposes of the Act shall be those appearing in the Schedule.

Revocation

3. The Labuan Offshore Business Activity Tax (Forms) Regulations 1991 [*P.U. (A) 157/1991*] are revoked.
